- state-licensed online casinos (online gambling), state-licensed betting on horse or dog races, betting activities including lottery tickets, casino chips, off-track betting, race betting, gambling for prizes with monetary value, and state lotteries;		
- purchases of goods or services and transactions at merchants for the repayment of loans and debts; transactions at merchants licensed to buy, sell and broker securities, shares, bonds, commodities and mutual funds; and transactions at merchants whose principal business is the sale of stored-value cards or accounts and their subsequent reload (including prepaid cards).
